Handelsstromen appelen veranderen; groeimarkten vooral buiten Europa

Polen in afgelopen seizoen (12/13) 's werelds belangrijkste exporteur

Wereldwijd wordt er (op commerciële schaal) naar schatting 75 miljoen ton appelen geproduceerd. Daarvan wordt ruim 10% in verse vorm internationaal verhandeld. In 2012 ging het om een hoeveelheid van 8,2 miljoen ton met een waarde van ca. 8 miljard dollar (6,4 miljard euro).

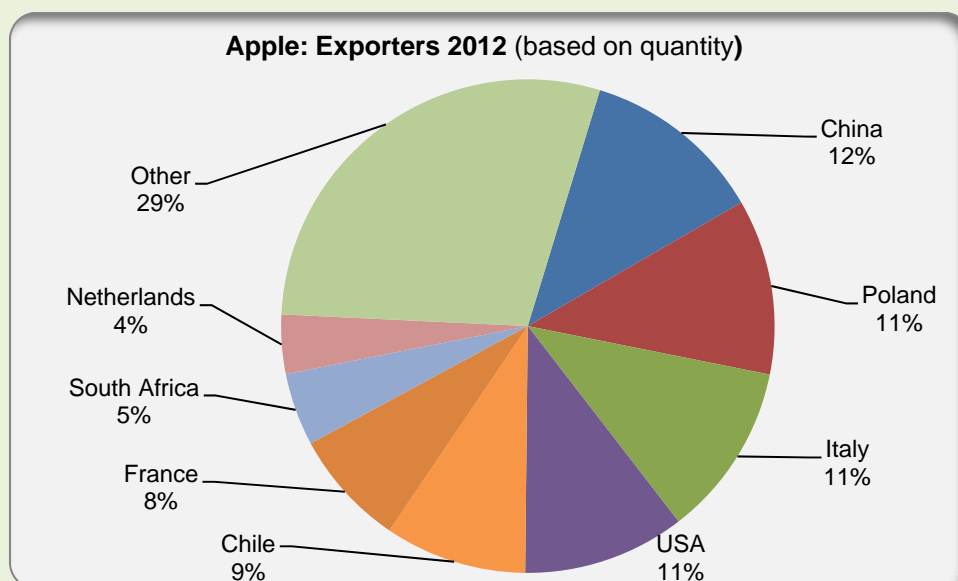
China is veruit de grootste producent van appelen. Dit land is in z'n eentje met 36 miljoen ton (cijfer FAO 2011) goed voor bijna de helft van de (commerciële) productie. Andere grote producenten zijn de Verenigde Staten (4,3 miljoen ton), India (2,9), Turkije (2,7), Polen (2,5), Italië (2,4) en Frankrijk (1,9). China was ook tot het afgelopen seizoen 's werelds belangrijkste exporteur. China exporteerde de afgelopen seizoenen ca. 1 miljoen appelen. Polen is in het afgelopen seizoen China echter voorbij gestreefd met een export van maar liefst 1,2 miljoen ton. Na deze twee grootmachten volgen Italië, de Verenigde Staten, Chili, Frankrijk en Zuid Afrika. Nederland staat (incl. re-export in 2012) op de 8^{ste} plaats.

Rusland voert meeste in

Rusland is wereldwijd gezien veruit de belangrijkste importeur van appelen. In het afgelopen seizoen (2012/13) was de Russische weer groter en werd er maar liefst 1,4 miljoen ton ingevoerd. Polen is veruit de belangrijkste leverancier en was ook het land dat in het Russische gat sprong. De import uit Polen nam met 60% toe naar meer dan 750.000 ton. Na Rusland is Duitsland de tweede op de lijst maar in het afgelopen seizoen zakte de import tot onder de 500.000 ton. Duitsland bleef daarmee Engeland nog net voor. De Engelse import van appelen groeide in het afgelopen seizoen naar een hoeveelheid van 487.000 ton.

Nederland is in omvang de vierde importeur met in het afgelopen seizoen een import van 330.000 ton.

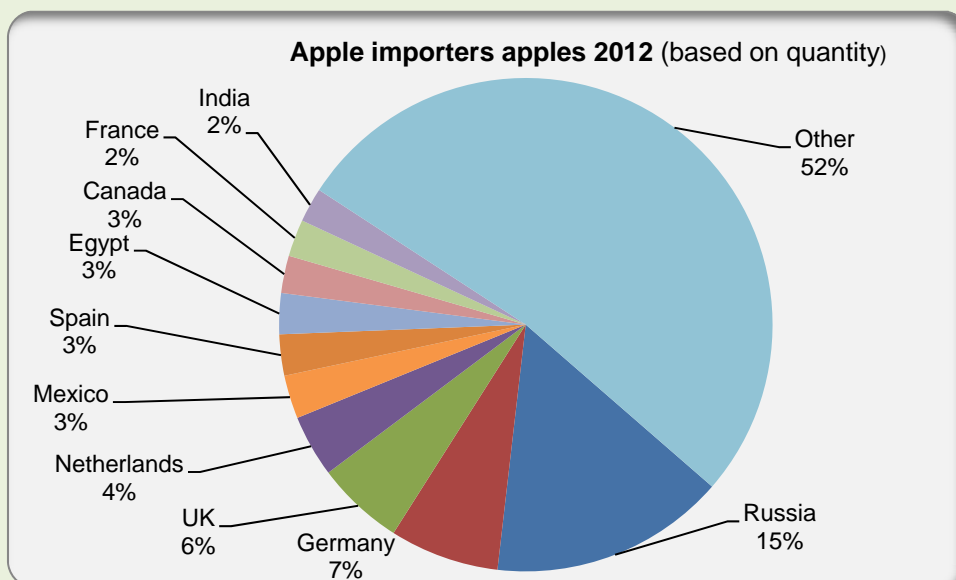
De internationale handel in appelsap is ook van aanzienlijke omvang. In 2012 had die een waarde van 3,3 miljard dollar. China is veruit de belangrijkste leverancier met Polen op afstand als tweede. De Verenigde Staten en Duitsland zijn de belangrijkste importlanden. Nederland is de 7^{de} importeur en als exportland valt Nederland net buiten de top-10.



Handelsstromen veranderd

De handelsstromen van appels zijn de afgelopen jaren wel veranderd. De bulk van de wereldhandel vind nog wel plaats door/van/met EU-landen. In het afgelopen seizoen exporteerden de EU-landen in totaal 3,6 miljoen ton. Bijna 60% bleef binnen de grenzen van de EU en 1,6 miljoen ging naar landen buiten de EU. Alle EU-landen samen exporteerden in 2012/13 870.000 ton naar Rusland waarvan 735.000 ton uit Polen en nog geen 5.000 ton uit Nederland tegen 18.000 ton in 2011/2.

Groeimarkten naast Rusland zijn: Mexico (vrijwel uitsluitend import USA-appels), Egypte (t/m 2012!; import vooral uit Italië, Syrië en Libanon), Canada (uit de USA), India (USA, China, Chili, Nieuw Zeeland), Indonesië (China en USA), Verenigde Arabische Emiraten (USA, Chili, China, Zuid Afrika, Nieuw Zeeland, Italië, Frankrijk), Saoedi Arabië (Chili, China, Italië, Frankrijk, USA), Thailand (China, New Zeeland, USA).



Meer ZHR-hardfruit

In de internationale handelsstromen van appels zien we de relatieve schaarste in West Europa ook terug in de marktverhoudingen. Zo hebben dit voorjaar de landen van het Zuidelijk Halfrond meer hardfruit kunnen exporteren, niet alleen naar EU-landen maar ook in z'n totaliteit. In de eerste helft van dit jaar konden de ZHR-landen in vergelijking met de eerste zes maanden van 2012 19% meer appels exporteren. De EU-vraag naar appels verschilde niet met die van overige landen.

Enorme export Poolse appels

Duitsland importeerde het afgelopen seizoen 10% minder appels. Het kleinere aanbod bij de traditionele leveranciers zoals Italië, Nederland en Frankrijk kon niet gecompenseerd worden door andere leveranciers. Polen sprong wel in het appelgat maar in het geheel gezien zette dit niet voldoende zoden aan de dijk.

Frankrijk heeft ondanks het kleine totaal aanbod in het afgelopen seizoen wel veel meer appels ingevoerd ook of juist uit de traditionele leverende landen zoals België, Spanje, Italië en Nederland. Het kleine aanbod in Europa heeft wel z'n weerslag gehad op de import in Rusland. In het afgelopen seizoen kon de Russische appelimport enigszins op peil blijven door de enorme import uit Polen.

Ook dit seizoen kleine Nederlandse oogst

Ook het lopende seizoen (2013/14) zal het aanbod van Nederlands appels niet echt groot zijn. Weliswaar is de verwachting dat er iets meer geoogst gaan worden als het vorige seizoen maar toen was de oogst zelfs de kleinste in de (recente) geschiedenis.

Vorig seizoen was in heel Europa de oogst klein. Dit is goed terug te zien in de internationale handelsstromen. De export van in Nederland geteelde appels was belangrijk kleiner dan de seizoenen er voor. In totaal werd er in het seizoen 2012/13 nog geen 70.000 ton Nederlandse appels uitgevoerd. Dat was resp. 30% minder dan in het seizoen er voor. De re-export bleef ook achter bij voorgaande seizoenen.

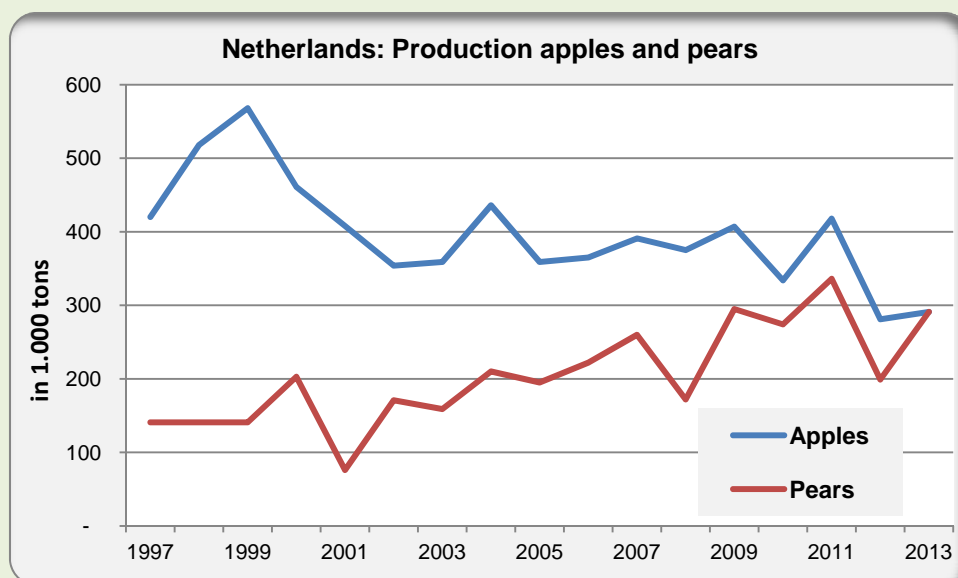


De Nederlandse appelimport was wel aanzienlijk (15%) groter dan het voorgaande seizoen. Vanwege de relatieve schaarste in het afgelopen seizoen waren de prijzen hoger. De waarde van de import van appels bereikte in het afgelopen seizoen bijna de grens van 300 miljoen euro. Aan De waarde van de export was vorig 280 miljoen.

Niet alleen in Nederland was de oogst vorig seizoen klein. Dat was het geval in vrijwel alle EU-landen. Alleen in Polen werd wel een behoorlijke oogst van de bomen gehaald. Dit seizoen worden er in de meeste EU-landen wel meer appels verwacht dan in het vorige maar overvloedig zal de oogst in e meeste landen niet worden. Appelgrootmacht Polen verwacht wel een aanzienlijke oogst waardoor het totaalbeeld vertroebeld wordt. Aan de andere kant ziet het er in landen als België en Duitsland slecht uit wat betreft de oogstverwachting.

Nederlands areaal peren inmiddels groter dan dat van appels

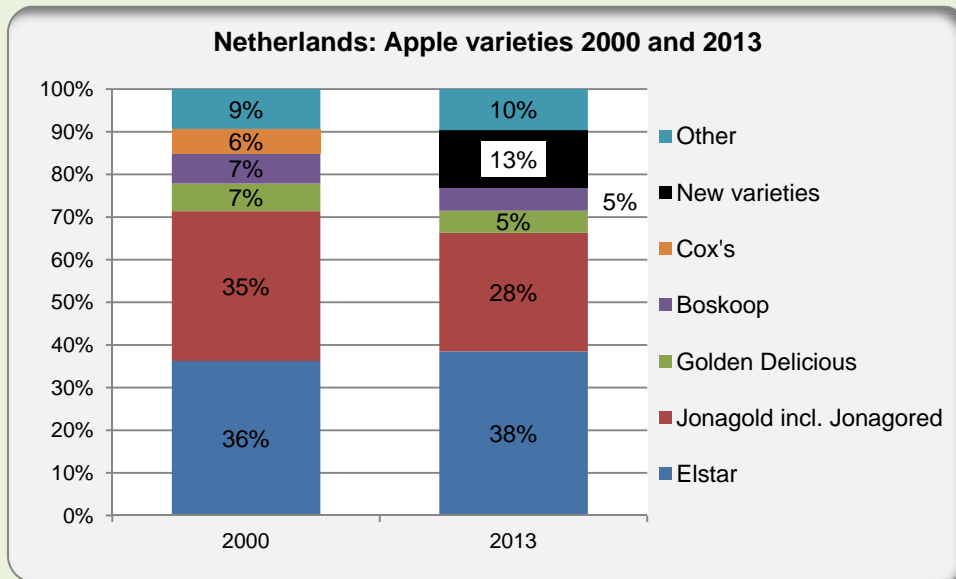
In Nederland neemt het areaal appels steeds verder af maar er komen wel steeds meer peren. Die trend zien we al jaren. In 2000 bedroeg het areaal beteeld met appels nog bijna 13.000 ha, dit jaar is dat nog geen 7.800 ha. In die zelfde tijd nam de teelt van peren toe van 6.000 naar 8.300 ha. Het rassenassortiment van Nederlandse appels is wel veranderd maar Elstar was en is het belangrijkste ras met een aandeel van nu 38% (2000 36%). Het aandeel van Jonagold/Jonagored is wel gedaald, van 36 naar 28%, maar dit ras is nog steeds met afstand de tweede. Elstar en Jonagold/Jonagored vertegenwoordigen samen nog altijd tweederde van de Nederlandse productie (in hoeveelheid gezien). De "nieuwe" rassen die er in 2000 nog niet waren vertegenwoordigen nu 13% van de productie.



Export Nederlandse appels: meeste naar Duitsland

Bij de export van Nederlands product is het aandeel van Elstar en Jonagold/Jonagored ook in die orde van grootte. Van alle Nederlandse appels die uitgevoerd werden ging vorig seizoen iets meer dan 30% naar Duitsland en 22% naar Frankrijk. Vooral de Franse vraag naar Nederlandse appels was vorig seizoen groot, er was in hoeveelheid gezien zelfs sprake van een verdubbeling. Er ging relatief gezien vooral veel Elstar (6.500 ton) en Jonagored naar Frankrijk (4.300 ton). Van dit laatste ras was Frankrijk zelfs de belangrijkste afnemer. Naar Duitsland gaat relatief gezien vooral veel Elstar. Bij Jonagold is Finland een belangrijke afnemer.





Re-export groter dan export Nederlands product

Naast appels van eigen bodem wordt er veel gehandeld in importproduct. Bij de totale export (incl. re-export) vormt het buitenlands product de meerderheid. In het afgelopen seizoen was van de totale appelexport (280.000 ton) driekwart re-export.

Bij de import van appels is het grootste deel bestemd voor re-export. Vorig seizoen was dit vanwege de krappe markt "maar" 64%, in het seizoen 2011/12 was het aandeel re-export in de import maar liefst 83%.

Van de productie van Nederlandse appels wordt het grootste deel in eigen land geconsumeerd (incl. verwerking). Vorig seizoen bleef driekwart van de Nederlandse appels in eigen land.

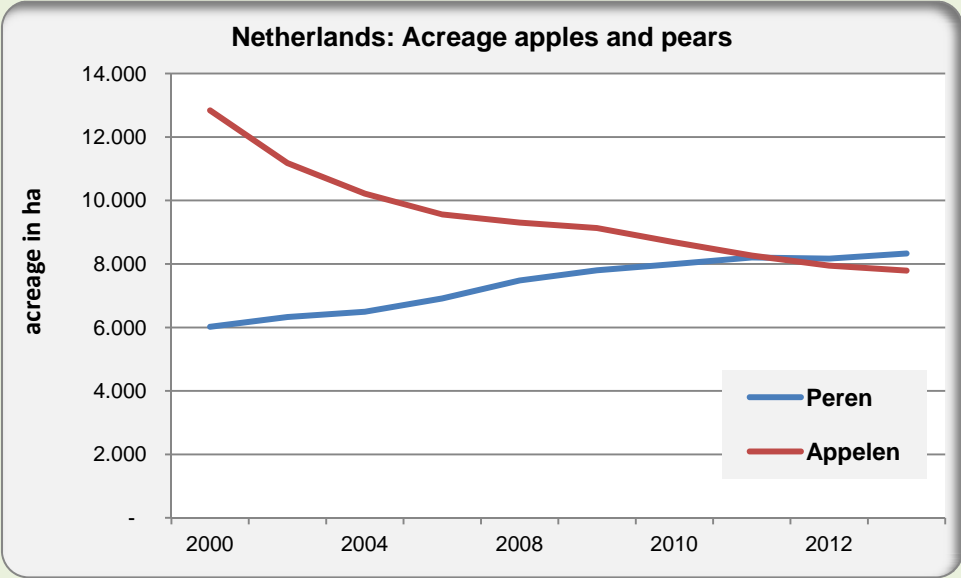
